### ORDER APPOINTING SPECIAL PROCESS SERVER

On March 14, 2017, the Staff of the Commission filed a Petition with the Missouri Public Service Commission asking the Commission to direct its General Counsel to petition the Circuit Court of Cole County to appoint a receiver for Ridge Creek Water Company, LLC, and Ridge Creek Development, LLC. The Commission will grant that motion.
