#### ORDER APPROVING TARIFF

Issue Date: December 11, 2017 Effective Date: December 15, 2017

On December 6, 2017, the Commission issued an Order Approving Stipulation and Agreement ("Order"). The Order rejected a previous tariff Missouri-American Water Company ("MAWC") filed, and authorized MAWC to file a tariff as the parties agreed in their Stipulation and Agreement.

Also on December 6, 2017, after the Commission issued the Order, MAWC filed a new tariff, denominated Tariff No. YW-2018-0073. That tariff is designed to implement the ISRS the Commission approved earlier that day in the Order.

The tariff bears an effective date of January 5, 2018. However, MAWC also filed a Motion for Expedited Treatment ("motion"), in which it asks the Commission to approve the new ISRS effective December 15, 2017. In the motion, MAWC points out that the parties agreed the new ISRS should become effective on December 15, 2017.

Staff filed a Recommendation on December 8, 2017, in which it stated the Commission should approve the tariff. The Commission allowed other parties to respond no later than December 8, 2017, but the Commission received no other responses.

The Commission has reviewed the tariff filing and Staff's verified recommendation.

The Commission will approve the tariff sheet to take effect on December 15, 2017.

#### THE COMMISSION ORDERS THAT:

- 1. The Motion for Expedited Treatment is granted.
- 2. The tariff sheet filed on December 6, 2017 by Missouri-American Water Company, Tariff Tracking Number YW-2018-0073, bearing the effective date of January 5, 2018, is approved to become effective on December 15, 2017.
  - 3. This order shall be effective on December 15, 2017.
  - 4. This file shall be closed on December 16, 2017.
