**ORDER SETTING PROCEDURAL SCHEDULE**

On August 29, 2017, Missouri-American Water Company (“MAWC”) filed an application and petition with the Commission, requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge (“ISRS”).<sup>1</sup> The Staff of the Commission (“Staff”) filed its Recommendation on October 29, in which it recommended a lesser ISRS amount. The Office of the Public Counsel (“OPC”) responded on November 9, disagreeing with MAWC and Staff. Both MAWC and OPC request a hearing.

Because the Commission must rule on the application no later than December 27, the Commission will set the hearing expeditiously.
