APPLICATION AND PETITION FOR ESTABLISHMENT OF AN
INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE

COME NOW Missouri-American Water Company ("MAWC"), pursuant to Sections 393.1000, 393.1003 and 393.1006 RSMo; and 4 CSR 240-2.060(1), and for its Application and Petition respectfully states as follows to the Missouri Public Service Commission (the "Commission"):

BACKGROUND

1. On August 28, 2003, three new Missouri statutory sections became effective in Chapter 393 RSMo. These new sections, 393.1000, 393.1003 and 393.1006, provide eligible water corporations with the ability to recover certain infrastructure system replacement costs outside of a formal rate case filing via the implementation of an Infrastructure System Replacement Surcharge ("ISRS"). Prior to implementing an ISRS, a petition must be filed with the Missouri Public Service Commission ("Commission") for review and approval before an adjustment can be made to a water corporation's rates and charges to provide for the recovery of the costs associated with eligible infrastructure system replacements.

THE APPLICANT

2. MAWC is a Missouri corporation with its principal office and place of business at 535 N. New Ballas Road, St. Louis, Missouri 63141. MAWC is a Missouri corporation in good standing. A Certificate of Good Standing from the Office of the Missouri Secretary of State was filed in Commission Case No. WM-2001-309 and is hereby incorporated by reference in accordance with Commission rule 4 CSR 240-

2.060(1)(G). MAWC currently provides water service to the public in and around the cities of St. Joseph, Joplin, Brunswick, Mexico, Warrensburg, Parkville, Riverside, Jefferson City, and parts of St. Charles and Platte Counties Missouri, and most all of St. Louis County, Missouri. MAWC currently provides water service to approximately 445,000 customers. MAWC provides sewer service to approximately 100 customers near Parkville, Missouri. MAWC is a "water corporation" and a "public utility" as those terms are defined in Section 386.020 and 393.1000(7) RSMo. 2000, and is subject to the jurisdiction and supervision of the Commission as provided by law. MAWC currently has a general rate case pending appeal (WR-2000-281) and a general rate proceeding pending before the Commission (WR-2003-0500). MAWC has no overdue Commission annual reports or assessment fees.

THE ISRS REQUEST

4. MAWC, per this application, requests an adjustment to its rates and charges through the implementation of an ISRS rate schedule to provide for the recovery of costs for infrastructure system replacements and relocations eligible for ISRS recognition. The proposed ISRS rate schedule should reflect the appropriate pre-tax ISRS revenues necessary to produce net operating income equal to MAWC's weighted cost of capital multiplied by the net original cost of the requested infrastructure replacements which are eligible for the ISRS, including recognition of accumulated deferred income taxes and accumulated depreciation associated with the aforesaid infrastructure system replacements. MAWC also seeks to recover all state, federal and local income or excise taxes applicable to such ISRS income and to recover all other ISRS costs such as depreciation expense and property taxes due within 12 months of this filing.

5. The infrastructure system replacements for which MAWC seeks ISRS recognition are put forth on Appendix "A", which is attached hereto and made a part hereof for all purposes. The infrastructure system replacements listed on Appendix "A" are eligible water utility plant projects in that they are either: a) mains and associated valves and hydrants installed as replacements for existing facilities that have worn out or were in a deteriorated condition; or, b) a main cleaning and/or relining project; or, c) an unreimbursed infrastructure facility relocation due to the construction or improvement of a highway, road, street, public way or other public work required by or on behalf of the United States, the State of Missouri, a political subdivision of the State of Missouri, or another entity having the power of eminent domain.

6. The infrastructure system replacements listed on Appendix "A" are eligible for ISRS treatment as they are water utility plant projects that: a) replaced and/or extended the useful life of existing infrastructure; b) currently are in service and used and useful; c) did not increase revenues by directly connecting to new customers; and, d) were not included in MAWC's rate base in its most recently completed general rate case.

7. The infrastructure system replacements listed on Appendix "A" for which ISRS recognition is requested, were performed within the boundaries of St. Louis County, Missouri. St. Louis County, Missouri has a charter form of government and is inhabited by more than one million people.

8. The former St. Louis County Water Company, which served most all of St. Louis County, Missouri prior to its merger with Applicant on December 31, 2001, as authorized by Commission Case No. WM-2001-309 had its last general rate proceeding decided by Commission Order issued on May 3, 2001, effective May 13, 2001 in Case No. WR-2000-844. Although probably not relevant due to the geographical limitations of ISRS applicability, MAWC had its last general rate proceeding decided by Commission order issued on August 31, 2000, effective September 14, 2000 in Case No. WR-2000-281. As stated previously, MAWC has a new general rate proceeding pending with the Commission, said proceeding having been filed on May 19, 2003.

9. This Application is MAWC's initial petition for the establishment of an ISRS.

RATE SCHEDULES AND SUPPORTING DOCUMENTATION

10. Attached hereto as Appendix "B" is the rate schedule and supporting documents proposed by MAWC in order to establish the ISRS and to provide for the adjustment of its rates and charges to reflect recovery of eligible infrastructure costs. This proposed rate schedule, on an annualized basis, will produce ISRS revenues of at least one million dollars, but not in excess of ten percent of MAWC's base revenue level as approved by the Commission in its most recently completed general rate proceeding.

11. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes current state and federal income tax rates of 6.25% and 35%, respectively.

12. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes the actual regulatory capital structure which reflects an overall rate of return of 8.59% as determined by the Commission for the former St. Louis County Water Company during its most recently completed general rate proceeding.

13. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes an actual cost rate for debt of 6.61% as determined by the Commission for the former St. Louis County Water Company during its most recently completed general rate proceeding. The former St. Louis County Water Company had no preferred stock at the time of its most recently completed general rate proceeding up to the point of merger.

14. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes a cost of common equity of 10.75% as determined by the Commission for the former St. Louis County Water Company during its most recently completed general rate proceeding.

15. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes a current composite property tax rate of 1.128% to the aforelisted eligible infrastructure system replacements in St. Louis County, Missouri.

16. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes depreciation rates currently applicable to the aforelisted eligible infrastructure system replacements in St. Louis County, Missouri as determined by the Commission for the former St. Louis County Water Company during its most recently completed general rate proceeding.

17. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes customer class billing determinants as utilized in designing the rates in St. Louis County, Missouri during the former St. Louis County Water Company's most recently completed rate proceeding.

18. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes the customer class cost-of-service study recognized by the Commission in St. Louis County, Missouri during the former St. Louis County Water Company's most recently completed rate proceeding.

19. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule utilizes the rate design methodology recognized by the Commission in St. Louis County, Missouri during the former St. Louis County Water Company's most recently completed rate proceeding.

20. In determining the appropriate pre-tax ISRS revenues, the proposed rate schedule identifies the classes of customers benefited by the aforesaid eligible water utility plant projects.

ADDITIONAL INFORMATION

21. MAWC will provide an initial (one-time) informational brochure (bill insert) to be distributed to its customers with the initial bills containing the Infrastructure System Replacement Surcharge (ISRS). This initial brochure, currently under development, will highlight what ISRS is and how it will benefit customers and enhance service reliability.

22. Beginning in the summer of 2004, MAWC will distribute an annual informational bill insert regarding ISRS and the impact it is having on enhancing the water system infrastructure in St. Louis County. It is anticipated that this bill insert will be sent in the months of July through September. (Design and content for this insert will be developed in spring of 2004.)

23. The ISRS charge will be clearly identified on the customer's billing statement. It will appear as a separate charge under ISRS. Additionally, for the initial billing cycles after its implementation, a bill message will be included on the bill explaining what ISRS is and the purpose for the new charge. The language for this bill message will be developed at a later date.

24. MAWC will post information on its website to inform customers of the new ISRS charge and the benefits of this new program. The information on this page of the website will reflect information provided in the bill inserts to be developed at a future date. The ISRS information will be posted to the Company's website upon the ISRS charge appearing on customers' bills.

25. The Company will provide the Public Service Commission with a copy of the talking points and information distributed to its customer call center. This information will be distributed approximately two weeks prior to the charges appearing on customer billing statements.

WHEREFORE, pursuant to 393.1006.2(3) Applicant respectfully requests the Commission to issue an Order bearing an effective date of no later than December 31, 2003 authorizing:

- (a) The Applicant to recover the costs of eligible infrastructure system replacements (as listed on Appendix "A") per the establishment and recognition of an ISRS. This ISRS recognition to be accomplished via an adjustment to MAWC's rates and charges by reflecting the appropriate pre-tax ISRS revenues necessary to produce net operating income equal to MAWC's weighted cost of capital multiplied by the net original cost of the requested infrastructure replacements which are eligible for the ISRS, including recognition of accumulated deferred income taxes and accumulated depreciation associated with the aforesaid infrastructure system replacements; and,
- (b) Granting such other relief as may be necessary and appropriate to accomplish the purposes of 393.1000 through 393.1006.





RATE I – Infrastructure System Replacement Surcharge (ISRS)*

DESCRIPTION – Rate I tariff is designed to recover the costs associated with the eligible Company's main, valve and hydrant replacements, main relocations, and main cleanings and relinings. This ISRS tariff and any future changes thereto, should be calculated and implemented in accordance with the provider of sections 393.1000 to 393.1006 RSMO.

AVAILABILITY – This rate is available to any customer class who benefits from the subject utility plant projects eligible for ISRS recovery. The surcharge shall be calculated consistent with the customer class cost-of-service study recognized by the Missouri Commission in the Company's most recent applicable general rate proceeding.

RATE COMPONENTS:

In addition to the other charges provided for in the Company's tariffs, a separate charge for the ISRS will be reflected on all bills rendered to customers on and after the effective date.
