On May 15, 2017, Missouri-American Water Company (“MAWC”) filed an application and petition with the Commission requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge (“ISRS”). Along with the application, MAWC filed an implementing tariff.

The Commission granted the Motion to Dismiss filed by the Office of the Public Counsel (“OPC”) on August 16, 2017, and no party requested rehearing. Thus, the order granting the motion to dismiss is final, and the Commission will reject MAWC’s tariff that would have implemented its requested ISRS.

THE COMMISSION ORDERS THAT:

1. Tariff No. JW-2017-0238 is rejected.

2. This order shall be effective when issued.
