SUPPLEMENT TO TARIFF FILING

COMES NOW Sprint Long Distance, Inc., now known as Embarq Communications, Inc. and hereby supplements its tariff filing to provide the Commission with more information regarding the planned customer notification.

1. On March 23, 2006, Sprint Long Distance, Inc. filed for a name change from Sprint Long Distance, Inc. to Embarq Communications, Inc. pursuant to 4 CSR 240-2.060(5). Accompanying Sprint Long Distance, Inc.'s tariff change was a Motion for Expedited Treatment.

2. Beginning around April 24, current SLDI customers will get a bill message regarding the name change from Sprint Long Distance, Inc. to Embarq Communications, Inc. The message will read:

Sprint Long Distance, Inc. change name to Embarq Communications, Inc.

On April 24, 2006, Sprint Long Distance, Inc., your long distance company, changed its name to Embarq Communications, Inc. You will see this change in the long distance section of your invoice. Please be assured that you will continue to experience the same reliable and dependable service you enjoy today, only the name has changed. If you have any questions, please call a customer service associate at 1-866-750-8300.


3. In addition to the bill message, these customers, along with other Sprint Missouri, Inc. customers, received a general direct-mail letter regarding the upcoming

name change from Sprint Nextel to Embarq. A sample copy of the general letter is included as Attachment A..

WHEREFORE, for the foregoing reasons, Sprint Long Distance, Inc., now known as Embarq Communications, Inc. seeks expedited approval of its proposed tariff so that the tariffs reflecting the name change to Embarq Communications may become effective on April 3, 2006.



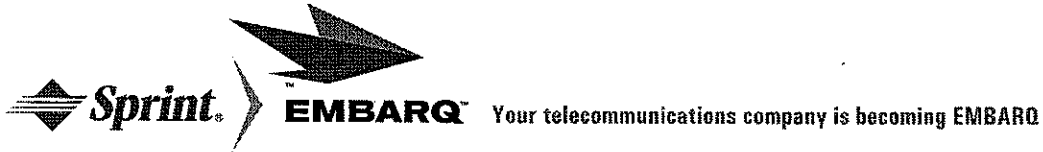
