**APPLICANTS' SUPPLEMENTAL FILING**

Transource Missouri, LLC, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company (“Applicants”) hereby advise the Commission that the final route for the regional Sibley-Nebraska City 345kV transmission project has been selected and publicly announced.

The Applicants hereby supplement the record with the final route notification letter to stakeholders (Exhibit A), maps of the final route of the Sibley-Nebraska City line (Exhibit B), and the press release issued on June 25, 2013 (Exhibit C).

The Applicants are developing a final list of utility lines crossed and other information required by 4 CSR 240-3.105, the Commission’s rule that governs the filing requirements for electric utility applications for certificates of convenience and necessity. The Applicants will file that information with the Commission when it is available.

Furthermore, the Applicants expect to receive from Burns & McDonnell in the near future a comprehensive compilation of materials that will describe in detail the siting, routing, easement, and right-of-way process related to the Sibley-Nebraska City line, which they also will file with the Commission

WHEREFORE, Transource Missouri, LLC, Kansas City Power & Light Company, and KCP&L Greater Missouri Operations Company respectfully supplement the record with the attached final route information for the regional Sibley-Nebraska City 345kV transmission project.
