**AMEREN MISSOURI'S SUPPLEMENTAL RESPONSE

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company), and provides the following information to supplement its August 1, 2011, response to the Missouri Public Service Commission's (Commission) *Order Directing Parties to Respond to Commission Inquiry*:

Undersigned counsel has polled employees of Ameren Missouri and Ameren Services Company (Ameren Services provides corporate support for Ameren Missouri), who might have knowledge about, or who might otherwise be involved in issues relating to Ameren Missouri's natural gas energy efficiency programs or proposed programs. The employees polled include those who are employed in the regulatory and natural gas energy efficiency areas of Ameren Missouri and Ameren Services, Company President and Chief Executive Officer Warner Baxter, each of Mr. Baxter's direct reports, as well as the attorneys who appear on behalf of the Company at the Commission. Each such person has indicated that he or she has not had any communication regarding Ameren Missouri's natural gas energy efficiency programs with any Commissioner, any Commission technical advisory staff member, or any Commission regulatory law judge in the 60 days prior to the filing of Tariff No. JG-2011-0620.

WHEREFORE, Ameren Missouri requests the Commission a grant a waiver of 4
CSR 240-4.020(2).
