Post-hearing briefs and proposed findings of fact and conclusions of law were due in these matters no later than April 27, 2007. On that same date, Respondents filed a motion for an extension of time in which to file these pleadings. Respondents state that other

pressing deadlines and scheduling conflicts have prevented essential communications with counsel concerning the final form of these pleadings. Respondents state that an extension until the end of the day on April 30, 2007 should allow sufficient time for these pleading to be completed and filed with the Commission. Respondents further assert that their request for an extension is not sought for the purposes of delay, but rather only because of excusable circumstances.

The Commission finds Respondents' request to be reasonable and shall grant it. The Commission will extend the deadline for filing post-hearing briefs and proposed findings of fact and conclusions of law until 8:00 a.m. on May 1, 2007. This extension will apply to all of the parties in these actions.
