On March 1, 2022, the Commission issued its Order Directing Notice, Setting Deadline for Intervention Requests, and Directing Filing of Staff Recommendation. That Order had an incorrect company reference. Ordered paragraph number 4 should read: "No later than April 25, 2022, Staff shall file a recommendation regarding Missouri-American Water Company's application." The original order incorrectly referenced Spire.

This Order Nunc Pro Tunc corrects Ordered paragraph number 4.

1.
