**MOTION FOR EXPEDITED TREATMENT**

COMES NOW Missouri-American Water Company (“MAWC”) and, in accordance with Missouri Public Service Commission (Commission) Rule 20 CSR 4240-2.080(14), moves the Commission for expedited treatment of certain tariff sheets filed on October 2, 2022:


1. On August 31, 2022 (effective September 9, 2022), the Commission issued its Order Granting Certificate of Convenience and Necessity (“Order”) in this matter. Therein the Commission authorized MAWC to acquire, and granted MAWC a CCN, to own, install, construct, operate, control, manage, and maintain the water and sewer system assets of Purcell, Missouri. Among other things, the Order further directed that MAWC submit “tariff sheets, to become effective before closing on the assets.”

2. MAWC filed the applicable tariff sheets this date and those sheets have been identified by Tracking Nos. YW-2023-0061 and YS-2023-0062, and contain a proposed effective date of November 1, 2022 (30 days).

3. The City of Purcell is prepared to close this transaction before the end of October. Accordingly, MAWC hereby seeks the Commission’s order allowing the proposed tariff sheets to go into effect on less than thirty days notice, to be effective October 25, 2022.

4. A grant of this motion will allow the transaction to move forward in a timely manner. There will be no negative effect on the customers or the general public from a grant of this motion and this motion has been filed as soon as it could be after the establishment of a closing date.

**WHEREFORE**, Missouri-American Water Company respectfully requests the Commission grant this Motion for Expedited Treatment and approve MAWC's proposed tariff sheets (YW-2023-0061 and YS-2023-0062) to be effective as of October 25, 2022.


