ORDER SHORTENING TIME FOR RESPONSES

On October 2, 2022, Missouri-American Water Company (MAWC) filed tariff sheets to comply with the Commission’s *Order Granting Certificate of Convenience and Necessity*. Those tariff sheets, Tracking Nos. YW-2023-0061 and YS-2023-0062, have an effective date of November 1, 2022. MAWC also filed a *Motion for Expedited Treatment*, stating that the City of Purcell, which is transferring the water and sewer assets, is prepared to close the approved transactions before the end of October. Thus, MAWC requests the tariff sheets go into effect on less than 30 days’ notice and become effective on October 25, 2022.

The Commission will shorten the time for responses to the tariff sheets and to the motion for expedited treatment. The Commission will also direct the Staff of the Commission (Staff) to file a recommendation regarding the tariff sheets.

THE COMMISSION ORDERS THAT:

1. Any responses to the tariff sheets, Tracking Nos. YW-2023-0061 and YS-2023-0062, shall be filed no later than 12:00 p.m., October 7, 2022.

2. Staff shall file a recommendation regarding the tariff sheets no later than 12:00 p.m., October 7, 2022.

3. This order is effective when issued.
