**STAFF RECOMMENDATION FOR APPROVAL OF COMPLIANCE TARIFFS**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and recommends that the Commission approve the proposed tariff sheets Missouri-American Water Company ("MAWC") filed on January 17, 2023, bearing effective dates of February 16, 2023.

1. On January 17, 2023, MAWC filed its proposed tariff sheets in tariff tracking numbers JW-2023-0129 and YS-2023-0130, with effective dates of February 16, 2023. Also on January 17, 2023, MAWC asked the Commission for expedited treatment of these proposed tariff sheets so they go into effect with less than 30 days' notice on February 10, 2023. Staff has no objection to the tariff sheets being effective with less than 30 days' notice.

2. On January 18, 2023, the Commission directed Staff to file a recommendation regarding these tariff sheets by no later than January 26, 2023, or a request for a time extension. Staff reviewed all tariff sheets and concluded that they comply with the Commission's January 11, 2023, Order Approving Stipulation and Agreement and Granting Certificate of Convenience and Necessity.
