STAFF'S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through counsel, and recommends that the Commission approve the tariff sheets Missouri-American Water Company (MAWC) filed February 13, 2023, bearing effective dates of March 15, 2023.

- 1. On January 11, 2023, in its *Order Granting Certificate of Convenience and Necessity*, the Commission granted MAWC a certificate of convenience and necessity to provide water and sewer service in and around the City of Smithton. The Commission also ordered MAWC to file new and revised tariff sheets before closing on the assets.¹
- 2. On February 13, 2023, MAWC filed new and revised tariff sheets in tariff tracking numbers YW-2023-0149 and YS-2023-0150, with effective dates of March 15, 2023. MAWC requested expedited treatment so the sheets take effect February 28, 2023, or as soon thereafter as is reasonable.
- 3. On February 14, 2023, the Commission directed Staff to file a recommendation regarding these tariff sheets and MAWC's request for expedited treatment by February 16, 2023.
