**REQUEST FOR ADDITIONAL TIME TO
FILE STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Request for Additional Time to File Staff Recommendation*, states the following:

1. On September 9, 2022, Confluence Rivers Utility Operating Company, Inc. (“Confluence Rivers”) filed two applications requesting that the Commission grant it a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, control, and manage the water system and sewer system assets of Stone Ridge Meadows Home Owners Association, Inc., (“Stone Ridge Meadows”) in an area of St. Charles County, Missouri. Confluence Rivers also requests Commission authorization to acquire the Stone Ridge Meadows assets. Confluence Rivers also requested waiver of the Commission’s rule requiring sixty days’ notice prior to filing an application.

2. And, on September 9, 2022, Confluence Rivers filed a *Motion to Consolidate* the two files – WA-2023-0092 and SA-2023-0093 – with WA-2023-0092 being designated the lead case. The Commission granted that motion on September 15, 2022. The Commission then ordered Staff to file a recommendation

regarding the applications, or to file a request for additional time on or before October 31, 2022.

3. Staff is presently collecting data for its recommendation. The additional time will allow Staff to incorporate recently acquired information.

4. The undersigned counsel emailed with applicant's counsel and with the Office of Public Counsel asking whether they object to this request. These counsel stated that they do not oppose this request.

WHEREFORE, Staff respectfully requests an extension until November 30, 2022 to file a recommendation.
