On March 14, 2023,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications regarding the acquisition of Four Seasons North MHP, LLC (Four Seasons). The Commission directed a recommendation or a request for an extension of time from its Staff (Staff) no later than May 1. Staff timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until June 21 due to outstanding data requests and a physical examination of the subject property. Additionally, Staff stated it is currently waiting to receive information from the Missouri Department of Natural Resources. Confluence responded with no objection. No other responses were received.

The Commission will grant the unopposed request for extension.
