On March 14, 2023,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications regarding the acquisition of Four Seasons North MHP, LLC (Four Seasons). The Commission directed a recommendation or a request for an extension of time from its Staff (Staff) no later than May 1. Staff timely filed a request for an extension of time to submit its recommendation.
