On April 5, 2023, Missouri-American Water Company (MAWC) filed the above-referenced application. The application seeks, among other things, authority for MAWC to acquire and operate the assets of a municipal water and sewer system in Wood Heights, Missouri.

The Commission will direct notice of the application be given to the county commission, local newspapers, and members of the General Assembly representing residents of Ray County, Missouri. The Commission will also direct notice of the application to the General Counsel for the Missouri Department of Natural Resources and will further set a deadline for interested parties to intervene.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commissions of Ray County, Missouri.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the members of the General Assembly

representing Ray County, Missouri and to the media serving Ray County, Missouri.

3. Any person wishing to intervene in this matter shall file an application to intervene no later than April 20, 2023. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the application can also be made in EFIS.

4. This order shall be effective when issued.
