Meetings Summary

Doug Collins started the meetings by providing a general overview of GridLiance and its business model. He also outlined GridLiance's partnerships with the Missouri Joint Municipal Electric Utility Commission, Tri County Electric Cooperative, Valley Electric Association, Inc., Kansas Power Pool, and Oklahoma Municipal Power Authority, and talked about the benefits for municipal utilities, joint action agencies, and electric cooperatives in partnering with GridLiance to solve transmission issues and manage transmission costs.

Doug Collins and Bary Warren then discussed some future operations plans that are in the works for GridLiance in Missouri. Bary informed everyone that GridLiance has opened its new branch office in Kansas City, Missouri, and how important Missouri is to GridLiance's future plans.

Sarah Galioto provided a status update regarding the City of Nixa transmisson assets acquisition. The Commission had previously granted South Central MCN, LLC (a subsidiary of GridLiance) a Certificate of Convenience and Necessity for these assets in Case No. EA-2016-0036.
