All parties shall be prepared to provide to the presiding officer via e-mail, electronic copies of any exhibits referenced during the hearing and/or offered into evidence during the hearing that were not included on the filed list of exhibits. Prior to a witness testifying via WebEx, counsel sponsoring the witness shall provide an e-mail address where the witness can receive and review exhibits during the hearing.
