On February 25, 2022, Missouri-American Water Company (MAWC) filed an application (Application) requesting Certificates of Convenience and Necessity for a water and sewer system in an area of Pettis County, Missouri (Monsees Lake Estates Subdivision).

On March 25, 2022, MAWC filed a motion to amend its application. As part of that filing, MAWC also filed the subject amendments to its Application. In sum, MAWC seeks to replace and amend Appendix C and Appendix D to its Application with the replacement Appendix C and Appendix D attached to its motion to amend its Application. Commission Rules allow that responses to any pleading can be filed within ten days.<sup>1</sup> No objections or responses were received.

The Commission will grant the uncontested motion for leave to amend the Application, and considers the Application so amended.
