Issue Date: December 15, 2022

On November 16, 2022, Missouri American Water Company (“Company”) filed proposed tariff sheets YW-2023-0091. These tariff sheets were filed in response to the Commission’s October 12, *Order Granting Certificate of Convenience and Necessity* (“Order”).

Staff filed a recommendation on December 2, stating that the tariffs comply with the Commission’s Order and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff’s recommendation.

Given Staff’s recommendation and no opposition to the tariff’s taking effect, the Commission will allow the Tariff sheets in Tariff No. YW-2023-0091 to take effect by operation of law on December 16, 2022.
