SECOND REQUEST FOR ADDITIONAL TIME TO FILE STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Second Request for Additional Time to File Staff Recommendation*, states the following:

1. On September 9, 2022, Confluence Rivers Utility Operating Company, Inc. (“Confluence Rivers”) filed an application requesting that the Commission grant it a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, control, and manage the water system and sewer system assets of Stone Ridge Meadows Home Owners Association, Inc., (“Stone Ridge Meadows”) in an area of St. Charles County, Missouri. Confluence Rivers also requests Commission authorization to acquire the Stone Ridge Meadows assets. Confluence Rivers also requested waiver of the Commission’s rule requiring sixty days’ notice prior to filing an application.

2. On September 15, 2022, the Commission ordered Staff to file a recommendation regarding the application, or a request for additional time, by October 31, 2022.

3. On October 31, 2022 Staff filed a *Request for Additional Time to File Staff Recommendation*, requesting the deadline to file a recommendation be moved to November 30, 2022.

4. On October 31 the Commission granted Staff’s request and ordered Staff’s recommendation due November 30.

5. Staff requests an additional 22 days to complete its analysis. The purpose of this request is not to cause undue delay or inconvenience to the parties or the Commission. Therefore, Staff requests a new date of December 22, 2022.

6. The undersigned counsel emailed with applicant's counsel and with the Office of Public Counsel asking whether they object to this request. These counsel stated that they do not oppose this request.

WHEREFORE, Staff respectfully requests an extension until December 22, 2022 to file a recommendation.
