Enclosed for filing with the Commission in the above-referenced case are an original and eight copies of Southwestern Bell Telephone Company's ("SWBT's") Supplement To Its Prior Ouarterly Monitoring Reports. The information contained in the Supplement is Highly Confidential as it provides market share information concerning SWBT's affiliate (SBC Advanced Solutions, Inc.) and network information of SWBT. This filing includes information for loops that were requested or provided through line-sharing arrangements and reflects the total number of loops requested for xDSL-based services and the number of such loops that required conditioning by binder group for each affiliate or non-affiliate in compliance with the Commission's Order Directing Filing in In the Matter of the Petition of DIECA Communications, Inc., d/b/a Covad Communications Company for Interconnection Rates, Terms, Conditions and Related Arrangements with Southwestern Bell Telephone Company, Case No. TO-2000-322, October 30, 2000. Also enclosed for filing is an original redacted ("NP") copy of SWBT's Quarterly Monitoring Report. As SWBT's affiliate, SBC Advanced Solutions, Inc. ("ASI") recently advised the Commission in Case No. TO-99-227, ASI has recently begun providing ADSL service via line sharing where conditioning is required to remove interferors (e.g. load coils) on loops between 12,000 - 17,500 feet where conditioning does not adversely impact the underlying voice service. This report reflects the conditioning required on loops subject to line sharing.

It is our understanding that SWBT's Quarterly Monitoring Reports are for the Commission's use only. SWBT, therefore, has not provided this Supplement to its Prior Quarterly Monitoring Report to the other parties in the above-referenced case.
