**STAFF'S SUPPORT OF TARIFF SHEETS AND NAME CHANGE**

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its Motion supporting the revised tariffs filed by Smithview H2O Company, formerly known as Suburban Water and Sewer Company, respectfully states to the Missouri Public Service Commission (Commission) the following:

1. On April 27, 2011, counsel for Smithview H2O Company filed with the Commission an Adoption Notice tariff sheet and the revised title page for Smithview H2O Company, formerly Suburban Water and Sewer Company.

2. Also on April 27, 2011, a Tariff Extension Letter was filed with the Commission by Smithview H2O Company requesting the effective date of the tariff filing for Smithview H2O Company be extended from April 30, 2011 to May 27, 2011, in an effort to provide the Commission the appropriate thirty (30) days' notice.
