ORDER DENYING APPLICATION FOR REHEARING

On January 25, 2022, the Commission issued an amended report and order regarding Foxfire Utility Company’s application to sell its water and sewer assets to Ozark Clean Water Company. That report and order became effective on February 4, 2023. On February 3, 2023, the Office of the Public Counsel (OPC) filed a timely application for rehearing.

Section 386.500.1, RSMo (2016), indicates the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, OPC has not shown sufficient reason to rehear the amended report and order. The Commission will deny the application for rehearing.

THE COMMISSION ORDERS THAT:

1. The Application for Rehearing of the Office of the Public Counsel is denied.
2. This order shall be effective when issued.
