## ORDER DIRECTING STATUS REPORT

On August 17, 2022, the Commission issued its Order Granting Application to Sell Assets. Effective September 16, 2022, the order granted the application of Rex Deffenderfer Enterprises, Inc. d/b/a RDE Water Company (RDE) for a Commission order authorizing the sale of its water system assets to the City of Nixa, Missouri.

One of the conditions of the sale was that RDE file a status report with the Commission if closing on RDE's assets would not take place within thirty (30) days of the September 16<sup>th</sup> effective date of the order. On October 7, 2022, RDE filed a status report in which it informed the Commission that the closing on the sale of the assets was scheduled for October 31, 2022.

The Commission will now direct RDE to file another status report as to whether the closing took place, as scheduled, on October 31<sup>st</sup>.

### THE COMMISSION ORDERS THAT:

1. No later than January 4, 2023, RDE shall file a status report stating whether closing on the sale of its assets has taken place and, if so, stating the closing date.
2. This order shall be effective when issued.
