ORDER CANCELING CERTIFICATE AND TARIFF, RELIEVING COMPANY OF FURTHER PUBLIC SERVICE OBLIGATION AND CLOSING CASE

On February 26, 2002, Quail Run Water and Land Company and the Public Funding Corporation of the City of Ozark, Missouri, filed their Joint Application seeking authority for Quail Run to sell its stock and system to Public Funding and, upon completion of the transaction, for Quail Run to quit the business. The Commission approved the transaction on June 11, 2002, and directed the parties to advise it when the transaction was closed. At that time, the Commission stated, it would "relieve Quail Run Water and Land Company of its obligation to provide water service to the public in its assigned service area and . . . cancel the certificate and tariff of Quail Run Water and Land Company."

On July 2, the parties notified the Commission that the transaction was complete. A sufficient interval has passed such that interested parties have had an opportunity to advise the Commission of any problems that might require the Commission to refrain from cancellation of Quail Run's certificate and tariff or to refrain from relieving the company of its public service obligation. No such information has been presented to the Commission.

Therefore, the Commission will cancel Quail Run's certificate and tariff and relieve it of its public service obligation.

IT IS THEREFORE ORDERED:

- 1. That the certificate of public water service authority issued to Quail Run Water and Land Company on June 22, 1990, in Case No. WA-90-142, is hereby canceled.
- 2. That the tariff under which Quail Run Water and Land Company has provided water service to the public is hereby cancelled. The specific tariff and sheets canceled are:

- 3. That Quail Run Water and Land Company is relieved of any further obligation to provide water service to the public in the state of Missouri.
 - 4. That this order shall become effective on August 2, 2002.
 - 5. That this case may be closed on August 3, 2002.
