STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby files its recommendation regarding tariff sheets PSC MO No. 19, PSC MO No. 19 1st Revised Sheet No. 1, and PSC MO No. 19 1st Revised Sheet No. 2, submitted in the above referenced case. In support of this recommendation, Staff respectfully states:

- 1. On June 12, 2013, Missouri-American Water Company (MAWC) and Tri States Utility, Inc. (Tri States) filed a joint application before the Public Service Commission (Commission) seeking authority for Tri States to sell substantially all its assets to MAWC.
- 2. On August 21, 2013, the Commission issued an *Order Approving Transfer of Assets, Granting Certificate of Convenience and Necessity, and Granting Waiver*, which authorized Tri States to sell and MAWC to acquire the assets identified in their application.
- 3. On September 5, 2013, MAWC filed a *Notice of Compliance* in which it notified the Commission that it had filed the following in Tracking No. YW-2014-0113: PSC MO No. 19 Original Sheet No. Adoption Notice; PSC MO No. 19 1st Revised Sheet No. 1, canceling PSC MO No. 1 Original Sheet No. 1; and PSC MO No. 19 1st Revised Sheet No. 2, canceling PSC MO No. 1 Original Sheet No. 2, all of which bear

an effective date of October 5, 2013. The following day, MAWC submitted a substitute sheet for PSC MO No. 19 1st Revised Sheet No. 2, cancelling PSC MO No. 1 Original Sheet No. 2.

- 4. On September 9, 2013, the Commission issued an *Order Directing Staff to File a Recommendation and Setting Deadline for Responses*, in which it directed Staff to review the new tariff sheets and file a recommendation on whether those tariff sheets are in compliance with the Commission's order.
- 5. In compliance with the Commission's *Order*, Staff has examined MAWC's filed tariff sheets. James A. Merciel, Utility Regulatory Engineering Supervisor in the Water & Sewer Unit of the Missouri Public Service Commission, participated in the review of this tariff filing and states that, to the best of his knowledge, information, and belief, the tariff sheets are true and correct and comply with the terms of the *Order* in this case. The Affidavit of James A. Merciel is attached here as Appendix A and incorporated by reference.

WHEREFORE, Staff submits this recommendation to the Commission stating that the tariff sheets filed in this case and pending in Tracking No. YW-2014-0113 comply with the terms of the Commission's *Order*.
