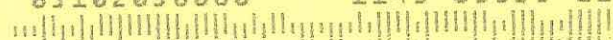

**ORDER DIRECTING STAFF TO EXPLAIN WHETHER COMPLAINT SHOULD
BE DISMISSED**

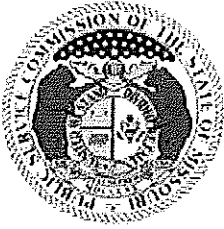

The Staff of the Commission filed a complaint with the Missouri Public Service Commission against Smithview H2O Company, John Kuhle, and Kuhle H2O, LLC on December 8, 2015, alleging that the Respondents have failed to provide safe and adequate services, have failed to file their annual reports, and have not paid their annual assessments to the Commission. No answer has been filed. On December 18, 2017, Staff filed a motion asking that this proceeding be stayed until a proposal to sell the company was resolved in File No. WM-2018-0116. The Commission approved the sale of the Smithview H2O water system in an order issued in File No. WM-2018-0116 on February 14, 2019.

The Commission will direct its Staff to indicate whether this complaint may now be dismissed.

THE COMMISSION ORDERS THAT:

1. No later than April 1, 2019, Staff shall file a pleading indicating whether this complaint should be dismissed.
2. This order shall be effective when issued.




