ORDER GRANTING LEAVE TO AMEND

On February 4, 2004, the Staff of the Missouri Public Service Commission filed a Complaint against Clear Call Telecom, LLC, for violation of the Commission's statutes and rules relating to annual report filings and annual assessments payments. Attached to the Complaint were Affidavits from Janis E. Fischer and Helen Davis. Also on February 4, 2004, Staff filed a Notice of Correction of Affidavit. Staff notes that the Affidavit of Helen Davis contains a typographical error in that it refers to the "Fiscal Year 2004 annual assessment" instead of the "Fiscal Year 2003 annual assessment." Staff requests that the Commission substitute the corrected Affidavit of Helen Davis.

The Commission issued a Notice of Complaint on February 10, 2004. The Notice of Complaint referred to and included a copy of Staff's Notice of Correction of Affidavit. The Commission finds that Staff's request is reasonable, is not opposed, and should be granted. The Commission will grant Staff leave to amend the complaint by substituting the corrected Affidavit of Helen Davis.

IT IS THEREFORE ORDERED:

1. That Staff's request to amend its Complaint is granted.
2. That this order shall become effective on April 1, 2004.


