AMEREN MISSOURI PROPOSED PROCEDURAL SCHEDULE

COMES NOW, Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri" or "Company"), and files this Proposed Procedural Schedule:

Procedural Background

1. On February 4, 2011, Mr. Jimmie E. Small, with a residence address of 606 West Highway #2, Milton, Iowa 52570 (Complainant) and a service address of 23 Lake Road Ct., 23067 Potter Trail, Kirksville, MO 63501, initiated this proceeding against the Company.
2. On April 21, 2011, the Commission issued its Order Regarding Proposed Procedural Schedules and Other Filings.

Proposed Procedural Schedule

3. In response to the Commission's Order Ameren Missouri recommends the following schedule:
 - a. As to discovery, the Company suggests that the parties have had ample time to serve discovery requests. The only discovery pending is Complainant's request for admissions, which was served on the Company on April 22. As such, the Company suggests that the time for serving discovery be closed and the deadline for responding to discovery be May 23, 2011.
 - b. The Company recommends that the parties file their respective proposed lists of issues and witnesses by May 13, 2011, so that the Commission may issue an order setting forth the order of witnesses and order of cross-examination in advance of the date of the evidentiary hearing.
 - c. The Company submits the following conflict dates (dates not available) for an evidentiary hearing between May 17 and June 17:
May 17 through May 20, inclusive; May 23; May 27; June 7, June 10; June 14.

WHEREFORE, Ameren Missouri respectfully requests that the Commission issue an order setting deadlines for discovery, setting a deadline for the parties to submit their respective lists of issues and witnesses, and setting the evidentiary hearing date.
