The Office of Public Counsel and the State of Missouri (the "State"), through the Attorney General, in response to the Commission's order dated April 18, 2003, state that the OPC and the State are not aware of any significant changes in federal or state law which have occurred since the filing of the motion described in the Commission's order.<sup>1</sup> Rather than file redundant pleadings, the OPC and the State rely upon the Commission's Staff to update the Commission on the status of pending related matters at the Texas, Arkansas, Kansas, and Oklahoma public utility commissions. OPC and the State will not be filing proposed findings of fact and conclusions of law on this matter.
