**UPDATED CALENDAR OF ISSUES AND PROPOSED ORDER OF
WITNESSES**

COMES NOW Missouri Gas Energy ("MGE") and submits an Updated Order of Witnesses. In support thereof, MGE states as follows:

1. On November 28, 2006, Staff filed its Joint Statement of Issues, Calendar of Issues and Order of Witnesses and Order of Cross-Examination in the referenced case. The order of witnesses in that filing was preliminary in nature because it preceded the filing of surrebuttal testimony on December 11, 2006. Now that the surrebuttal testimony has been filed in the case, the parties submit to the Commission an updated order of witnesses with respect to the issues still remaining to be heard in this case.
2. The parties suggest the following order of witnesses consistent with the Commission's December 8, 2006 Pre-Hearing Order.¹

As such, it has been added to the tabulation above to be heard on Friday, January 12, 2006. The undersigned regrets the oversight.

WHEREFORE, MGE request an order from the Commission adopting the Updated Calendar of Issues and Order of Witnesses as set forth in paragraph 2, *supra*, and for such other orders as may be appropriate in the circumstances.
