Schedule of Service Charges

Bills will be mailed on a monthly basis and will indicate the last date on which payment will be considered timely. The customer is allowed a minimum of 21days from bill rendition (mailing) to pay their bill, after which time it will be considered to be delinquent.

Deposit or Guarantee Requirements

The Company may require a deposit or guarantee as a condition of new or continued service.

Billing and Estimated Billing

Water bills are mailed monthly. The bills provide the beginning and ending meter readings dates, water usage, and previous or credit balances and the bill due date. Estimated billings may occur in cases of extreme weather conditions, emergencies or lack of access to the customer's premises.

Customer Payment

Payment due date is the 21st day of the month. Payments may be made in person at the office or by mail.

Termination of Service, Disconnection and Reconnection

Service will be discontinued for non-payment of delinquent accounts with prior notification to the customer. Service will not be restored without prior payment of the delinquent amount plus turn-on and turn-off fees.

Service may be discontinued by the customer by giving a minimum of 24 hours notice to the Company during its regular office hours that water service is to be discontinued.

To avoid discontinuance of service during a period of absence from the address please contact the office with the information concerning length of absence, alternate billing address or pre-payment based on estimated averages.

Responsibility for Distribution Mains, Service Connections and Water Meters.

In general, the company is responsible for repairing and maintaining the distribution mains, the water meters, and the service lines and connections up to the meter, and you are responsible for all lines, connections etc. from the meter to and inside your property and home.

Valley Wood Water Company. Inc. is a regulated public utility and you as its customer are governed by applicable law including but not limited to Chapters 386 and 393 of the Missouri Revised Statutes and title 4. Division 240 of the Missouri Code of State Regulations.

This information is being provided in accordance with CSR 240-13.040, which rules of Missouri Public Service Commission which regulate investor owned utilities.

The customer has a right under procedures in 4 CSR 240-2.070 to file formal or informal complaint with the MO Public Service Commission. 
