## **APPLICATION**

Valu-Line of St. Joseph, Inc. ("Valu-Line") and Communigroup of K.C., Inc. (CGI) (together "Applicants"), through their undersigned counsel and pursuant to Section 392.300 RSMo 2000, 4 CSR 240-2.060 and 4 CSR 240-3.520 hereby request that the Commission grant the authority to enable Valu-Line to consummate a transaction by which all of Valu-Line's long distance telecommunications and telecommunications services, business, customers, products and support will be transferred to CGI. In support of this request, Applicants state as follows:

A. Description of the Applicants

## Valu-Line

Valu-Line is a Missouri corporation with its principal business office located at 6950
West 56th Street, Mission, Kansas 66202. Valu-Line's Certificate of Good Standing issued by the
Missouri Secretary of State is attached as *Exhibit 1*.

2. Valu-Line is certificated by this Commission to provide interexchange telecommunication services throughout the State of Missouri.

## C. <u>Description of the Transaction</u>

5. Valu-Line and CGI have entered an Asset Purchase Agreement<sup>1</sup> (the Transaction) pursuant to which CGI proposes to acquire the core operations, operating assets, customer base and associated authorizations of Valu-Line. Specifically, CGI proposes to acquire the regulated communications assets associated with Valu-Line's long distance operations, including the associated telecommunications equipment, existing customer base, and federal and state licenses and/or certificates authorizing those operations.

6. Resolutions authorizing the Transaction approved by the shareholders and boards of directors of each company are attached as *Exhibit 3*.

## D. <u>Public Interest Considerations</u>

7. The proposed transaction will have no impact on tax revenues of any political subdivision in which structures, facilities or equipment of the Applicants are located.

8. Neither Valu-Line nor CGI has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or customer rates, which action, judgment or decision has occurred within three (3) years of the date of this Application.

9. No annual reports or fees are overdue for either company.

10. Applicants respectfully submit that this Transaction is not detrimental to the public interest. Applicants submit that the Transaction will not diminish competition in the Missouri telecommunications market and is designed to minimize disruption of service to existing customers

to whom the Transaction will be virtually transparent.




