### STAFF STATUS REPORT ON AFFILIATE TRANSACTIONS RULEMAKING

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and files this status report on affiliate transactions rulemaking.

1. In this case, the Commission ordered that within 90 days of its *Report and* 

*Order's* effective date, Staff file a status report stating when affiliate transactions rules will be filed to begin a formal rulemaking.<sup>1</sup>

2. On July 19, 2023 Staff filed a status report and its revised fourth draft of rules in the affiliate transactions rulemaking case, File No. AW-2018-0394. Staff concurrently filed a status report and its revised third draft of rules in File No. AW-2018-0393, which deals with treatment of customer information.

3. As Staff wrote in these two status reports, Staff's opinion is that the draft rules are ready for the Commission to proceed with formal rulemaking cases. To assist with preparation of fiscal notes, Staff requests that the Commission invite stakeholders to file comments within 30 days regarding costs of compliance with these rules.<sup>2</sup> The Commission has not ruled on this request.
