On June 15, 2023, Missouri-American Water Company (MAWC) filed the above-referenced tariff sheet. The tariff sheet was filed to allow customers who had signed up for a pilot low-income program to continue to receive its benefits even after the program's May 28, 2023 expiration. The tariff sheet bears an effective date of July 15, 2023.

The Commission will order its Staff to file a Recommendation, and will also allow other parties to respond.

1. The Commission's Staff shall file a Recommendation no later than June 27, 2023.
