**ORDER DIRECTING SUBMITTAL OF TARIFF SHEETS**

On December 9, 2022, the Staff of the Commission (Staff) filed a disposition agreement in this case regarding the disposition of a small utility company revenue increase request in accordance with the provisions of Commission Rule 20 CSR 4240-01.075(11)(A). That disposition agreement was signed by Staff and Argyle Estates Water Supply (Argyle) and purported to provide for a full resolution of this small utility rate case.

Commission Rule 20 CSR 4240-10.075(11)(C) requires a utility to submit new and/or revised tariff sheets, bearing an effective date no fewer than 45 days later, concurrently with Staff's filing the disposition agreement. Argyle has not filed the required tariff sheets.<sup>1</sup> The Commission will direct Argyle to submit the new and/or revised tariff sheets called for in the Commission's rule.

**THE COMMISSION ORDERS THAT:**

1. No later than December 30, 2022, Argyle Estates Water Supply shall file tariff sheets in compliance with Commission Rule 20 CSR 4240-10.075(11)(C) in this case.
