ORDER DIRECTING RESPONSES REGARDING LOCAL PUBLIC HEARING

Effective Date: April 11, 2023

On April 4, 2023, Raytown Water Company filed a letter requesting an increase in its annual overall operating revenues in a staff assisted rate case. Commission Rule 20 CSR 4240-10.075(6) requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case, unless all parties agree that a local public hearing is not necessary. In this case, that deadline is Saturday, June 3, 2023.

The Staff of the Public Service Commission filed a rate case timeline for this case, as required by 20 CSR 4240-10.075(5). The timeline anticipates providing notice of a local public hearing to customers by mail on or about April 24, 2023. Written notice of a local public hearing must be mailed to customers at least 10 days prior to hearing.¹

The Commission will direct the parties to file a response recommending locations and dates for a local public hearing.

THE COMMISSION ORDERS THAT:

1. No later than April 18, 2023, the parties in this case shall file a joint response listing recommended dates and locations for a local public hearing.
2. This order shall be effective when issued.
