ORDER SETTING PROCEDURAL SCHEDULE FOR DISCOVERY AND LIST OF ISSUES

Issue Date: May 16, 2011

Effective Date: May 16, 2011

The Commission is setting a procedural schedule and terms.

The theories discussed by Jimmie E. Small at the pre-hearing conference require a refinement of the pleadings. Also, the Commission must adjust the dates projected in the order to file proposed procedural schedules¹ because of the responses to that order.² On consideration of those events, the proposed procedural schedules filed, and the desire to facilitate the fair processing of this action, the Commission will order the following schedule and terms.

A. Schedule. The procedural schedule shall be as follows.

B. Discovery and Responses to Discovery. As used in this order, discovery includes any data request and subpoena.

C. List of Issues. Jimmie E. Small shall file a list of issues organized as follows. For each provision of tariff, regulation or statute of which Mr. Small claims a violation, he shall set forth:

- a. A citation to such provision.
- b. Allegations of fact that show a violation of the provision.
- c. The remedy that Mr. Small seeks for such violation.

D. Response to List of Issues. Any response to the list of issues:

- a. Shall admit, deny or state a lack of knowledge as to each allegation.
- b. May allege additional facts relevant under any provision cited in the List of Issues.
- c. May include a motion to dismiss if the facts alleged in the List of Issues, taken as true, show no violation of the respective provision cited.

E. Further Procedure. Upon the completion of this schedule, the Commission will issue such orders as then appear necessary to the resolution of this action.

THE COMMISSION ORDERS THAT:

1. The schedule and terms set forth in the body of this order are adopted.
2. This order shall be effective immediately upon issuance.
