In fact, Mr. Bundridge states that "NWMC is unable to provide Lifeline plans without ETC support."<sup>26</sup> A commitment 6 to provide Lifeline and Link Up discounts and Missouri Universal Fund discounts are 7 requirements placed upon carriers seeking ETC designation.<sup>27</sup> Therefore, NWMC is not 8 required to offer Lifeline plans without ETC support. 9 10 **O**. Will NWMC offer Lifeline and Link Up with USF support? 11 Α. NWMC states they will offer two Lifeline only plans. The first, for \$9.70 per month will 12 include only the "traditional ILEC calling area for the subscriber's address."<sup>28</sup> The other 13 14 plan for \$13.70 per month will include the entire service area for NWMC. NWMC did not provide adequate information with the second plan on the number of minutes that 15 16 would be included or the charge for minutes over those unknown minutes. Additionally, 17 NWMC states they will offer Link Up discounts of 50% off the \$35 activation fee and establish a deferred non-interest payment plan not to exceed one year for the \$200 18 connection charge.29 19 20
