Jonathan D. Reeves

1 In March of 2005, I founded JDR Telecom Solutions, LLC. ("JDR"), which
2 provides technical representation to telephone companies, personal communications,
3 cellular, paging, microwave and other wireless communication carriers and
4 entrepreneurs.

5 **Q. To what professional associations do you or your firm belong?**

6 A. The firms that I have worked with have been Associate Members of the Rural
7 Cellular Association, the Rural Telecommunications Group ("RTG"), the
8 Organization for the Promotion and Advancement of Small Telecommunications
9 Companies ("OPASTCO"), the National Telephone Cooperative Association
10 ("NTCA") and various states Telecommunications Association.

11 **Q. What professional services have you provided to Northwest Missouri Cellular
12 Limited Partnership ("NWMC")?**

13 A. I have performed a network analysis of the NWMC existing cellular network and
14 provide ongoing network optimization services. I have analyzed existing network
15 coverage and, under the direction of Mr. Roger Bundridge and Ms. Kathryn G.
16 Zentgraf, I have performed analysis of areas where the existing CDMA network
17 would benefit from enhancement and the coverage that would result from the
18 deployment of proposed additional cell sites using proprietary propagation and
19 system analysis software. I have analyzed NWMC's coverage and advised NWMC
20 concerning infrastructure modifications that would improve and expand reliable
21 coverage provided to its subscribers.

22 **Q. Have you provided testimony in previous portions of this proceeding?**

1 A. Yes. I previously provided direct testimony with regard to NWMC's Application For
2 Designation As An Eligible Telecommunications Carrier for Purposes of Receiving
3 Federal Universal Service Support Pursuant to Section 214(e)(2) Of The
4 Telecommunications Act Of 1996 ("Application") in this docket.

5 **Q. What is the purpose of your testimony in this proceeding?**

6 A. My testimony will support and expand upon certain statements and factual
7 representations in NWMC's Application For Designation As An Eligible
8 Telecommunications Carrier for Purposes of Receiving Federal Universal Service
9 Support Pursuant to Section 214(e)(2) Of The Telecommunications Act Of 1996
10 ("Application") in this docket. Additionally, my testimony will address the
11 requirements identified in the Missouri Public Service Commission's pending Order
12 of Rulemaking for rule 4 CSR 240-3.570 that was adopted after NWMC's application
13 was submitted.

14 **Q. Are you familiar with the Missouri Public Service Commission's pending Order**
15 **of Rulemaking for rule 4 CSR 240-3.570?**

16 A. Yes, I have reviewed the pending Order, and based on the requirements I have
17 personally prepared Highly Confidential Appendix O, attached hereto, which
18 graphically depicts the current NWMC CDMA coverage as well as the site location
19 of the current cell towers. This Exhibit has been included to specifically address
20 Section 2.A.3.A of the pending Order that requires a map of the coverage area before
21 and after improvements. Highly Confidential Appendix G of the Application was
22 previously submitted and shows the coverage area after improvements.
