IT IS THEREFORE ORDERED:



2. 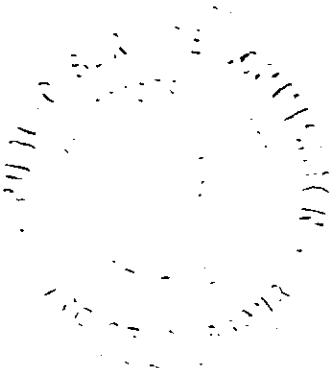
