

Please be advised that after making a payment of \$1,000 to KCPL on May 21st , we were disconnected on May 24th for an undetermined amount one statement says 891.90 while the PHONE still reports over 2,000 which will ineffect cancel or inhibit AGENCY assistance...we are displaced from our home and can be contacted at 816-923-2307 at the home of a family member. We would note that on May 31, 2013 at approximately 12:20 KCPL reps/field staff were on the PROPERTY not do RE-CONNECT and not NOTICE of there presence was left on the PROPERTY. I arrived at my house at 12:30 and they had left I noted the KCPL Meter no other changes and no apparent reason for the PRESENCE of EMPLOYEE'S at the premises. Neighborhood watch is taking pictures of all activity at my residence while I am out of the HOME and to maintain Documentation about anyone on the PROPERTY while we are absence. I would request PRIOR NOTIFICATION for such visits unless pertaining to RECONNECTION as we are in an Adversarial position and KCPL is suspect of RETALIATION . We have concerns about KCPL's presence during our ABSECE during this time. Thank you!
