ORDER REGARDING ADMISSION OF PREFILED TESTIMONY AND
OTHER DOCUMENTS AT HEARING

The hearing for these matters is set to begin on February 28, 2007. The parties are prefilng testimony per the Commission's order setting the procedural schedule issued on January 26, 2007. The parties are advised that even though testimony, pleadings or other documents have been filed with the Commission that none of these filings have been

formally offered into or received into evidence. The parties will be offering their evidence at hearing where it will be subject to any cognizable legal objection. The parties are expected to provide proper foundation and authentication for the admission of evidence. The parties offering evidence will be allowed to defend their offering against any objections to their admission. The presiding officer will rule on any objections at hearing.

It was stated in the Commission's order setting the procedural schedule; "All parties are required to bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. If an exhibit has not been prefiled, the party offering it should bring, in addition to the copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel." However, the presiding officer is now directing the parties to bring sufficient copies of all documents for the court reporter, the Commissioners, the presiding officer and all counsel. The parties will bring said copies, even if the testimony, documents or exhibits have been prefiled.

Some documents and exhibits were prefiled in Case No. WA-2006-0480, a related case that is now dismissed. Should the parties wish to offer any of these materials into evidence in this hearing, they shall bring sufficient copies for the court reporter, the five Commissioners, the Presiding Judge, and all counsel.

IT IS ORDERED THAT:

1. All parties shall comply with the requirements for offering evidence at hearing as directed in the body of this order.

2. This order shall become effective on February 22, 2007.
