BUDGET PREPAY, INC.'S SUPPLEMENT TO APPLICATION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

COMES NOW Budget PrePay, Inc. ("Budget PrePay"), pursuant to 4 CSR 240-2.080 and for its Supplement to Application for Designation as an Eligible Telecommunications Carrier states as follows:

1. Pursuant to Staff's inquiry, Budget PrePay expressly confirms it will comply with

all requirements identified in Commission Rule 4 CSR 240-31.050, which pertains to eligibility

requirements for funding of low-income and disabled customers

2. Pursuant to Office of Public Counsel's inquiry, Budget PrePay hereby provides an

additional description of the rates and features of its services:

Budget PrePay provides a Basic Service and Double Feature Service. While priced the same, the Double Feature Service is an added value offer that competitively positions Budget PrePay against services provided by competing carriers. The Basic Service offering is still made available to remain in compliance with State mandates and provides a value to customers who may require a restriction of their calling features. Both plans include 60 minutes of long distance service each month for added value. Through both of these offerings, Budget PrePay hopes to provide customer value and satisfaction, based on the unique needs of the customer.

3. Pursuant to Office of Public Counsel's inquiry, Budget PrePay will publicize the availability of Lifeline and Link-Up services by means of materials such as those attached hereto as **Exhibit 4**. Budget PrePay's agent distribution and payment center network is an integral part of its unique service as these agents operate in locations where low-income and credit impaired customers conduct business. As a result, Budget PrePay will direct a large portion of its Lifeline advertising strategy to point of purchase materials in rent-to-own centers, check cashers, wire transfer centers, convenient stores or grocery stores. Budget PrePay will provide agents with banners, posters and product flyers for in-store merchandising to create an immediate impact and make the public aware of the availability of its Lifeline offering. Budget PrePay will also provide print ads that the agents can run in various print media.

4. Pursuant to Office of Public Counsel's inquiry, Budget PrePay confirms it will provide the exact local calling scope that AT&T provides for the basic local rate (i.e. without an additional charge for expanded local calling).

5. Pursuant to Office of Public Counsel's inquiry, Budget PrePay confirms it will not be offering optional local calling scopes for an extra charge.
