## STATUS UPDATE

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its status update in this matter respectfully states:

- 1. On July 10, 2000, the Staff filed a motion recommending that the Commission cancel Providian Group, L.L.C.'s ("Providian") certificate of service authority to provide intrastate interexchange telecommunications services, granted on February 17, 1997 in Case No. TA-97-261, and accompanying tariff. Staff gave notice of its motion via United States Mail to Mr. Jayme Amine, CEO of Providian, and to Providian's attorneys who filed the application.
- 2. In accordance with the procedure directed by the Commission in similar cases, Staff gave notice, via certified United States Mail return receipt requested, to Mr. Amine and to Providian's attorneys of Staff's motion recommending the Commission cancel Providian's certificate of service authority and tariff. Subsequently, the United States Postal Service ("USPS") returned the letter addressed to Mr. Amine as undeliverable and marked "Unable to Forward." The USPS returned the receipts showing delivery of the letters addressed to Providian's attorneys.
