APPLICATION

COMES NOW Union Electric Company, doing business as AmerenUE ("Applicant" or "AmerenUE"), and submits its Application pursuant to Section 393.170, RSMo. 2000 for permission and authority to construct a 34.5 kilovolt ("kV") line. Applicant requests that the Missouri Public Service Commission ("Commission" or "MPSC") issue an order by November 1, 2003, in order to ensure the timely implementation of the proposed line and to provide reliable service to Applicant's customers. In support of this Application, AmerenUE states as follows:

AmerenUE, in good standing in all respects, with its principal office and place of business located at 1901 Chouteau Avenue, St. Louis, Missouri 63103. Applicant is engaged in providing electric and gas services in portions of Missouri as a public utility under the jurisdiction of the Commission. Applicant is also engaged in providing electric and gas service in portions of Illinois. There is already on file with the Commission a certified copy of Applicant's Articles of Incorporation and Certificate of Corporate Good Standing (see MPSC Case No. EF-2003-0514), and Applicant's Fictitious Name Registration as filed with the Missouri Secretary of State's Office (See MPSC Case No. GO-98-486), and said documents are incorporated herein by reference and made a part hereof for all purposes.

- 3. The 34.5 kV line that Applicant proposes to construct, operate, own and maintain will be approximately 12.6 miles in length. The proposed line will begin at a point from Matthews Substation in New Madrid County to East Prairie Main Substation in Mississippi County. Approximately 5.5 miles of the proposed line is outside of Applicant's certified service area. The legal description for the proposed line outside Applicant's certified service area is set forth in Exhibit 1 which is attached hereto and made a part hereof. The Application seeks approval for only the portion of the line outside of Applicant's service area. State ex rel. Harline v. PSC, 343 S.W.2d 177 (Mo. 1960).
- 4. The route of the proposed line is shown on the drawing which is attached hereto, marked as Exhibit 2, and made a part hereof.
- 5. The proposed line will be constructed using single pole wood structures averaging 50 feet in height. No razing or demolition of any manmade structures is anticipated as a result of the construction.
- 6. The proposed line will be constructed in accordance with the requirements set forth in 4 CSR 240-18.010.
- 7. The estimated cost of the project, including the proposed line, right-of-way costs, and substation construction is \$2.9 million. Financing for the project will be from funds

available in Applicant's treasury, a portion of which may be obtained by new financing. The amount and nature of any new financing subject to the jurisdiction of the Commission will be submitted to the Commission for approval.

- 8. Copies of the franchises granting Applicant the right to erect, construct, operate and maintain one or more electrical lines upon, along, under, across and over public places within the Counties of Mississippi and New Madrid are attached hereto as Exhibit 3.
- 9. Electric and telephone utilities, in addition to companies having underground facilities as defined in Section 319.015, RSMo. 2000 whose facilities will be crossed by the proposed line in Missouri, are as follows: St. Johns Bayou Basin Drainage District, SEMO Electric Cooperative, and Southwestern Bell Telephone. Copies of letters from those companies waiving objection to the proposed construction are provided will be filed upon receipt.
- 10. This 34.5 kV circuit extension has multiple benefits that are necessary to comply with good utility practice. The chief benefit of this 34.5 kV circuit extension is a quick restoration of service during an outage of the major area supply 161-34.5 kV transformer near Charleston, Missouri. This transformer is part of the supply for the towns of Charleston, Anniston, East Prairie, and associated areas. An outage of this transformer would leave nearly 1,460 customers/households out-of-service for approximately a three-week window. The 1,460 customers/households is approximately 9,000 kVA, which corresponds to the electrical system limit.

The other benefit of this 34.5 kV circuit extension is associated with quick restoration of service for three separate overhead line outages. These three overhead lines are: a 161 kV 10.5 mile line from Miner, Missouri to Charleston, Missouri, a 34.5 kV 10.6 mile line from Charleston, Missouri to East Prairie, Missouri, and a 34.5 kV 16.0 mile line from Miner,

Missouri to Matthews, Missouri. During an outage of any one of these lines, nearly 1,460 customers/households may be without service during a 6 to 24 hours window. With this line extension, these customers would not be out of service for the above stated outages, and good utility practice will have been maintained.

- 11. The proposed line is scheduled to be placed in service in June, 2004. In order to meet the required in-service date, it is necessary that construction begin by November 1, 2003.
- 12. Applicant has given notice of the proposed line to affected public officials in the Counties of New Madrid and Mississippi, Missouri, and has discussed the matter with Commission Staff. Applicant has also notified all affected property owners of the proposed line.
- 13. To the best of AmerenUE's knowledge, it has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involves customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application. In addition, AmerenUE has no annual report or assessment fees that are overdue.

WHEREFORE, Applicant prays that an order be issued by November 1, 2003, granting Applicant permission and authority to construct, operate, own and maintain the proposed 34.5 kV line in New Madrid County, Missouri, and Mississippi County, Missouri, and that the Commission make such other order or orders as it deems just and proper.






