ORDER APPOINTING MEDIATOR

On March 1, 2012, Big River Telephone Company, LLC ("Complainant") filed a complaint with the Missouri Public Service Commission ("Commission") against Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri ("Respondent"). On March 2, 2012, the Commission issued an *Order Giving Notice of Contested Case and Directing Answer*, requiring Respondent to file an answer to the complaint or request mediation no later than April 2, 2012. Respondent filed a *Request for Mediation* on March 26, 2012. On April 2, 2012, the Commission issued an order requiring Complainant to respond to the *Request for Mediation*. On April 13, 2012, Complainant filed a response agreeing to the Respondent's request for voluntary mediation. As permitted by Commission Rule 4 CSR 240-2.125, the Commission will stay all other proceedings in this matter while the parties mediate.

Pursuant to Commission Rule 4 CSR 240-2.125(2), the Commission hereby appoints Kennard Jones, Senior Regulatory Law Judge, as Mediator. The assigned mediator shall convene an initial conference to discuss a procedural schedule, and each party should be prepared to present its position informally to the Mediator at the initial conference. <u>No materials utilized for mediation shall be filed under this case number to</u> <u>ensure the impartiality of the Presiding Officer and the Commission should mediation fail to</u> <u>resolve the dispute</u>.

THE COMMISSION ORDERS THAT:

1. This case is stayed pending the outcome of mediation, which shall be conducted by Kennard Jones, Senior Regulatory Law Judge.

The parties shall mediate their dispute pursuant to Commission Rule 4 CSR
240-2.125.

3. No later than May 1, 2012, the parties shall contact the appointed Mediator,

Kennard Jones, Senior Regulatory Law Judge, at the Missouri Public Service Commission,

314-340-4700 ext. 24, to initiate the mediation process.

4. No later than May 1, 2012, each party shall submit to the Mediator a written statement summarizing the dispute and shall furnish such other material and information it deems appropriate to familiarize the Mediator with the dispute.
